## **ROAD COMMITTEE MEETING MINUTES**

### October 4, 2016

A three person delegation from the Maple Lane Road was next introduced to the Road Committee. Tom Morrison addressed the members about various issues that the owners of property have regarding any possible cost sharing on upgrading the south half of Maple Lane. The committee was informed that Tulloch Engineering has been engaged to provide estimates and quantities for bringing the road up to Municipal standards. The Road Superintendent will be meeting with Tulloch representatives on October 11<sup>th</sup>.
