WHEREAS the POA Board of Management is concerned with the current financial status of the Provincial Offences Act – Gore Bay Court Services.

AND WHEREAS Gore Bay is operating at a deficit of \$22,000.00 which is unprecedented;

AND WHEREAS the deficit is directly attributable to the restrictions imposed by the Providence as it relates to the Province's response to the COVID 19 situation;

AND WHEREAS the Province has had almost one year to find a solution to ensure the safe and continued operations of the Provincial Offences Court system in Ontario;

AND WHEREAS the Province transferred the POA operations to municipalities in 2000 with the expectation that it would operate on a profit and not negatively impact the financial status of the participating municipalities;

THEREFORE BE IT RESOLVED THAT the Gore Bay POA Board of Management lobby the Provincial Government to provide COVID 19 Support funds go to all POA Court Operations in the Province of Ontario;

FURTHER all POA Court Offices in the Province of Ontario be asked for to support this motion by sending letters to the Premier of Ontario, Ministry of Attorney General and local MPP'S asking for action to provide financial assistance to all municipal POA Offices impacted by COVID 19......carried.
