#### **Motion: MacDonald and Baran**

That we recommend to Council that they consider including a 50/50 shared cost for the Providence Bay Arena Kitchen renovation with an estimated total cost of \$25,000.00 in the preliminary 2017 property capital budget discussions and further that the PBCC board will revise and finalize the project estimates at their December 2016 meeting...carried.

Discussions for the use of Roads Department surplus funds will be addressed at the Roads Committee capital budget meeting.

The correspondence between Brian Mitchell, President of the Providence Bay/Spring Bay Lion's Club and the CAO / Clerk was reviewed.
