That Council directs that the following motion from the Drainage Advisory Committee be sent to the Planning Board:

Whereas Ontario's Provincial Policy Statement and Manitoulin's Official Plan require the protection and conservation of areas susceptible to flooding, sensitive surface and ground water features, and other Hazardous Lands; and

Whereas these areas are critically important to local and migratory wildlife, flora, and a healthy, sustainable environment; and

Whereas the protection, prevention of building or development or adverse grading or site alterations on these lands will ensure they are available for wildlife, as a reservoir for excess precipitation and runoff, and help reduce the risk of flooding for all other nearby lands and built-up areas; and Whereas there is a general lack of information, understanding, and sense of importance for the role these lands play in protecting our ecosystem and builtup areas;

Therefore Central Manitoulin's Drainage Committee hereby recommends to Council that Council consider the following:

- 1. Central Manitoulin's Council review the current By-laws protecting lands susceptible to flooding, sensitive surface and ground water features, and other Hazard Lands, and if necessary, draft and pass a strengthened or new By-law; and
- 2. Land susceptible to flooding, sensitive surface and ground water features, and other Hazard lands be more accurately defined, mapped, and clearly designated as such; and
- 3. All property owners of lands susceptible to flooding, sensitive surface and ground water features, and Hazard Lands be notified in writing of this designation, and the resulting advantages and responsibilities; and
- 4. Communication and awareness programs be implemented or facilitated by the Municipality to raise awareness, knowledge, support, and consensus in Central Manitoulin's citizens, visitors, and surrounding areas about areas susceptible to flooding, sensitive surface and ground water features, and other Hazard Lands; and
- 5. Programs for aiding and recognition of landowner's proper conservation and management be established for areas susceptible to flooding, sensitive surface and ground water features, and other Hazard Lands; and
- 6. Consideration be made for nominally preferable property tax rates and/or other incentives for landowners of areas susceptible to flooding, sensitive surface and ground water features, and other Hazard Lands; provided the landowner consistently meets the minimum necessary conditions of the program;
- Active enforcement of Ontario's Provincial Policy Statement, Manitoulin's Official Plan, and Central Manitoulin's By-law (to be reviewed and strengthened, or newly developed) that requires the protection of areas susceptible to flooding, sensitive surface and ground water features, and other Hazard Lands...carried.
