

MUNICIPALITY OF CENTRAL MANITOULIN

ROAD COMMITTEE MINUTES – SEPTEMBER 7, 2021

VIA ZOOM

Attending: Chairperson Councillor D. Stephens, Mayor R. Stephens, Councillors Diebolt, Johnston, Scott, Shaffer and Tribinevicius, along with the CAO/Clerk, the Road Superintendent and three members of the public.

The Chairperson called the meeting to order at 7:00 p.m.

**MOTION: R. Stephens and Shaffer**

That the agenda be approved with the addition of item 7.a. Bruce Beatty request for snowplowing-Mountain View Resort.....carried.

There were no declarations of pecuniary interest.

There were no delegations.

**MOTION: Johnston and Tribinevicius**

That the minutes of the last regular meeting of the Road Committee held on August 3, 2021 be approved.....carried.

Old Business: a. UMIT-next meeting will be on September 9, 2021 at 3:00 p.m.

b. Speed Limit on Highway 551 entering Mindemoya from the North-this is part of the discussions with MPP Mike Mantha and MTO.

c. Flashing School Zone sign quote -to be discussed during the 2022 capital budget proceedings.

d. Intersection of Highways 542 & 551- a consensus was reached that the Municipality would like to see an overhead flashing amber and red light at this intersection.

Other items for discussion during the meeting with MTO/MPP Mike Mantha/Council Members and Staff on September 8, 2021: a. Plastic lane dividers during the summer months, straightening the signage at the four corners, lowering the height of the no parking signs, changing the colour of the no parking painted strips, painting a large no parking sign on pavement with a P and slash through it, the stop sign coming in from the North on Highway 551 is being blocked by the No Parking sign in front of it.

**MOTION: Shaffer and D. Stephens**

That we recommend to Council that the Road Department place signage that there is a Public Beach and Public Parking on Idyl Glenn Road.....carried.

**MOTION: Shaffer and Tribinevicius**

That the CAO/Clerk respond to the petitioners on Lake Huron Drive, that the request for a speed reduction on this road is not warranted and that the radar traffic statistics be forwarded to them.....carried.

**MOTION: R. Stephens and Shaffer**

That the CAO/Clerk respond to the petitioners on Coventry Road, that the request for a speed reduction on this road is not warranted and that the radar traffic statistics be forwarded to them.....carried.

**MOTION: Shaffer and Johnston**

That we recommend to Council that the Providence Bay sidewalk replacement and extension be considered during the 2022 Capital budget considerations.....carried.

The Road Superintendent was asked to fill in the potholes on the Idyll Glen Road as needed.

**MOTION: Tribinevicius and R. Stephens**

That we recommend to Council that the CAO/Clerk respond to Ken Leslie's request to snow plow the approximately 4.5 kilometers of the south portion of the East Road, that there will not be winter maintenance of this road.....carried.

**NOTION: Shaffer and Tribinevicius**

That we recommend to Council that the CAO/Clerk respond to Bruce Beatty's request for snow plowing of the laneway into Mountain View Resort off Nighswander Road, that the Municipality does not plow on private property.....carried.

**MOTION: R. Stephens and Shaffer**

That we accept the radar speed statistics for the following areas: Highway 551, High 542, Lake Huron Drive and Coventry Road.....carried.

**MOTION: Johnston and Tribinevicius**

That we recommend to Council that the year-to-date financial report for the Road Committee ending August 31, 2021 be approved.....carried.

**MOTION: R. Stephens and Shaffer**

That we accept the Road Superintendents monthly report.....carried.
