That the minutes of the last regular meeting of the Road Committee held on August 4, 2020 be approved......carried.

Trevor Aljoe was introduced to the committee. Mr. Aljoe requested that the Municipality build a roadway adjacent to his property at 114 Limberlost Lane on Hillcrest Road so that he can access the property from the west side. Mr. Aljoe also requested that the speed limit on Digby Road be set at 20 km. per hour. It is currently set at 40km. per hour.

The committee further discussed the opening of Hillcrest Road. The Road Superintendent was asked to provide a firmer cost for doing so. The committee discussed the idea of asking the adjacent landowners to cost share the project, as has been done in the past for Frank's Road and Maple Lane.
