THEREFORE BE IT RESOLEVED that the Township of Central Manitoulin supports the Federation of Northern Ontario Municipalities as the unified voice of Northeastern Ontario and in its creation of these task forces to focus on these priorities; and

WHEREAS FONOM has undertake to form seven task forces to pursue the major issues of concern to Northeastern Ontario; and

WHEREAS FONOM has suggested a fee of \$0.05 per capita from its member municipalities to help fund this ambitious research and lobbying effort; now
