MUNICIPALITY OF CENTRAL MANITOULIN PROPERTY COMMITTEE MEETING MINUTES August 9, 2016

Attending: Chairperson Mayor R. Stephens, Councillors Baran, Farquhar, Scott and D. Stephens along with the Municipal Coordinator, the Maintenance Supervisor, 1 member of the public and 1 member of the press.

The meeting was called to order at 7:00 p.m.

Motion: Scott and Baran

That the agenda be approved with the addition of 7e – Providence Bay Community Centre Board minutes – August 3, 2016 including 3 recommendations to Council and 1 request to review and 10 – In Camera...carried.

Councillor Scott made a declaration of pecuniary interest on item 8c. Item 8c.: Letter from Holly Scott – Canada's 150th Birthday Garden.

That the minutes of the Property Committee meeting held on June 14, 2016 be approved...carried.

Mike Bridgeman, lead on a committee to investigate the replacement and options for a new multi-use facility for the Municipality presented a list of possible committee members and was offered other possible suggestions for candidates. Mr. Bridgeman continued with a brief preliminary presentation of examples of various possible structures and designs.

The Maintenance Supervisor presented his status report for the Mindemoya Old School.

The Mindemoya Arena East Wall project was updated by the Municipal Coordinator.

An update of the Mindemoya Fire Hall design was presented by the Municipal Coordinator.

A direction to staff was made to organize an onsite meeting of the Mindemoya Fire Hall Design Committee to make the necessary plans to proceed with the appropriate clearing of the site in preparation for the construction process next spring. The Maintenance Supervisor reported on his attempts to secure costing for the repair of the front steps at the Providence Bay Community Centre. He will present his findings at the next Property Committee meeting.

The Ontario 150 Community Capital Program memo from the Municipal Coordinator was presented and discussed.

A request to stop the dumping of fish guts on the Providence Bay beach was discussed by Committee.

Staff has been directed to confirm property ownership in the area and report findings at the September 13, 2016 Committee meeting.
