# Municipality of Central Manitoulin Safety, Security and Health Committee Minutes April 26<sup>th</sup>, 2016

Attending: Chairperson Councillor Farquhar, Councillors Baron, D. Stephens and Taylor along with the Fire Chief and the Administrative Assistant, Dr. Roy Jeffery (delegation – Assisted Living) and one member of the public. The Mayor sends his regrets.

The meeting was called to order at 7:01 p.m.

#### **MOTION: D. Stephens and Baran**

That the agenda be approved ......carried.

There were no declarations of pecuniary interest.

The committee received a delegation of Dr. Roy Jeffery who is representing Manitoulin Assisted Living. Although the issue was presented to committee at their last meeting, the committee invited Dr. Jeffery because they needed more information regarding the issue. Dr. Jeffery explained that the concept of Manitoulin Assisted Living is still in its very early stages, and that much more work needs to be done. The first step would be to try and secure property to build on. All Manitoulin municipalities co-own the parcel of land on which the manor is situated. Dr. Jeffery said that he believes if the municipalities are willing to allow the severance of a portion of the Centennial Manor lands, then his group would be able to secure funds to build the project. Dr. Jeffery relayed that his group cannot proceed with a detailed business proposal needed for funding until they have secured the property.

Whereas the Municipality of Central Manitoulin recognizes the need for Assisted Living facilities on Manitoulin Island; we recommend to Council to support Dr. Roy Jeffery's proposal in principal, but reserve the right to make its support contingent upon satisfactory development of a business plan that includes such things as an Admissions Policy, Capital and Operating Plans, and other areas of concern to the municipality......carried
