By-Law 2016-19 authorizing the Municipality to enter into an agreement with her Majesty the Queen in Right of Ontario, as Represented by the Minister of Rural Affairs in order for the Municipality to receive its share of the Ontario Community Infrastructure Fund – Formula Based Component was reviewed.

That we recommend to Council that By-Law 2016-19, being a By-Law to authorize the Mayor and Clerk as designated signing officers and authorizing the execution of the Contribution Agreement with Her Majesty the Queen in Right of Ontario, as represented by the Minister or Rural Affairs be given three readings and duly pass...carried.
