MUNICIPALITY OF CENTRAL MANITOULIN

BY-LAW NUMBER 2009-06

BEING A BY-LAW TO AMEND THE MUNICIPALITY OF CENTRAL MANITOULIN'S RESTRICTED AREA ZONING BY-LAW NUMBER 2002-07 (AS AMENDED)

WHEREAS the Planning Act, R.S.O., Section 34, provides for the amendment of Bylaws.

AND WHEREAS the Council of the Municipality of Central Manitoulin has received a request to amended Restricted Area By-law 2002-07 (as amended) as it applies to property described as, Part lots 28 & 29, Range B, Registered Plan 31R-1637 Part of Sub-lot 2, and as shown on Schedule 'B' (attached), in the Township of Carnarvon, Municipality of Central Manitoulin, District of Manitoulin.

AND WHEREAS the Municipality of Central Manitoulin has ensured that adequate information has been made available to the public and has held at least one (1) public meeting after due notice for the purpose of informing the public of this by-law;

NOW THEREFORE the Council of the Municipality of Central Manitoulin enacts as follows:

1. That Section 8 – Special Provisions of the Municipality of Central Manitoulin's Restricted Area Zoning By-law be amended to add:

Section 8.34

To permit the use of an existing structure as a sales/rental office and to allow for the Development of a "Tourist cabin establishment" with a maximum of six rental cabins on Part lots 28 & 29, Range 'B' Registered Plan 31R-1637 being part of sub-lot 2, in the Township of Carnarvon, Municipality of Central Manitoulin.

- 2. All other permitted uses, performance standards and provisions of Restricted Area Zoning by-law Number 2002-07 as amended which are not specifically varied hereby continue to apply.
- 3. That Schedule "A" of Central Manitoulin By-law 2002-07 shall form part of this by-law.
- 4. That schedule "B" as attached shall form part of this By-law.
- 5. That By-laws 2008-27, 2004-07 and 2008-17 are hereby rescinded.
- 6. That this by-law shall come into force and take effect on the date of its final reading subject to the expiration of the 20 day appeal period, provided in Section 34(18) of the Planning Act and subject to approval of the Ontario Municipal Board where objections to this by-law are filed with the Municipal Clerk.
