

**MUNICIPALITY OF CENTRAL MANITOULIN**

**BY-LAW NUMBER 2009-13**

BEING A BY-LAW TO AMEND THE MUNICIPALITY OF CENTRAL MANITOULIN'S RESTRICTED AREA ZONING BY-LAW NUMBER 2002-07 (AS AMENDED)

WHEREAS the Planning Act, R.S.O., Section 34, provides for the amendment of By-laws.

AND WHEREAS the Council of the Municipality of Central Manitoulin has received a request to amended Restricted Area By-law 2002-07 (as amended) as it applies to property described as, Part lot 24, Concession 2 , Registered Plan 31R-3170 Part 2, and as shown on Schedule 'B' (attached), in the Township of Campbell, Municipality of Central Manitoulin, District of Manitoulin.

AND WHEREAS the Municipality of Central Manitoulin has ensured that adequate information has been made available to the public and has held at least one (1) public meeting after due notice for the purpose of informing the public of this by-law;

NOW THEREFORE the Council of the Municipality of Central Manitoulin enacts as follows:

1. That Central Manitoulin Restricted Area Zoning By-law 2002-07 as amended is hereby further amended by changing the existing zoning on Lot 24 Concession 2, RP- 31R-3170, part 2, Township of Campbell, from (CR) Commercial Recreational to (SR) Shoreline Residential.
2. That Section 8 – Special Provisions of the Municipality of Central Manitoulin's Restricted Area Zoning By-law is amended to add:

Section 8.36

To site specifically allow for an increase of allowable floor space in an accessory building located on a residential lot from 46 sq. mtrs. to 96.25 sq. mtrs. on Part lot 24, Concession 2, Registered Plan 31R-3170 part 2, in the Township of Campbell, Municipality of Central Manitoulin.

3. All other permitted uses, performance standards and provisions of the Shoreline Residential zone as described in Restricted Area Zoning by-law Number 2002-07 as amended which are not specifically varied hereby continue to apply.
4. That Schedule "A" of Central Manitoulin By-law 2002-07 as amended shall form part of this by-law.
5. That schedule "B" as attached shall form part of this By-law.
6. That this by-law shall come into force and take effect on the date of its final reading subject to the expiration of the 20 day appeal period, provided in Section 34(18) of the Planning Act and subject to approval of the Ontario Municipal Board where objections to this by-law are filed with the Municipal Clerk.
