COUNCIL MEETING MINUTES - MARCH 14, 2014

The Mayor called the meeting to order at 7:30 p.m.

50-14 MOTION: Haner and Taylor

That the agenda be approved as presented......carried.

There were no declarations of pecuniary interest.

51-14 MOTION: McDonald and Taylor

That the minutes of the last regular Council meeting held on February 27, 2014 be approved......carried.

52-14 MOTION: McDonald and Haner

That Council supports in principal the redesign of the southern portion of the Mindemoya Arena and further that the amounts originally budgeted (\$10,000) for the Arena doors be utilized for the engineered redesign of the arena or placed in a reserve for that said purpose...carried.

53-14 MOTION: McDonald and Taylor

That Council approves that the Municipality contract for three (3) monitoring wells for the Providence Bay Landfill with cost to come out of reserves...carried.

54-14 MOTION: McDonald and Haner

That Council accepts the Providence Bay Landfill Monitoring Report provided by Gamsby and Mannerow LTD. and further that it be distributed to the appropriate parties...carried.

55-14 MOTION: McDonald and Haner

That Council supports the Ride Manitoulin Beer Garden as long as it meets the requirements of the upcoming Alcohol Policy...carried.

56-14 MOTION: McDonald and Taylor

That Council approves the 2014 Water & Sewer Budget as presented ...carried.

57-14 MOTION: McDonald and Taylor

That Council approves the year to date financial report for the month of January 2013 for the Public Works Committee as presented...carried.

58-14 MOTION: McDonald and Taylor

Whereas in light of the fact that a municipality must have a 50% turnout of eligible electors vote on a referendum question and 50% + 1 of those must vote in favour of a referendum question in order for it to pass;

And Further upon review of the past three municipal elections in which there was less than 50% voter turn out;

And Further Council, not wanting to force the municipality to bear the expense of holding an election when it may not be necessary;

Now Therefore Council withdraw the proposed referendum question "Do you support a Council review of the existing ward system that might result in amending or eliminating the existing ward structure? "......carried.

59-14 MOTION: Taylor and Haner

The Council approves that the municipality go out for a request for proposal for engineering services for a two year period with a 90 day opt out clause.....carried.

The Mayor announced that the Municipality had received funding in the amount of \$ 1, 440,000,00 from the Small, Rural and Northern Municipal Infrastructure Fund for the Yonge Street Road reconstruction project.
