That Council approve that item # 4 of the lease agreement between the Municipality and the Providence Bay Seniors Twilight Club be revised as follows: That the downstairs room and kitchen of the Providence Bay Centennial Hall will be for the use of the Club only and will be rented out only after obtaining approval from the Club president or designee for a rental rate of \$ 45.00 payable directly to the Club and further that the lease agreement be for a four year term concurrent with Council's term of office...carried.
