THE MUNICIPALITY OF CENTRAL MANITOULIN

BY-LAW NO. 2022-16

Being a By-law to Amend Zoning By-law No. 2002-07

Being a By-law for the purpose of amending Zoning By-law No. 2002-07, being a By-law, to regulate the Use of Land of the Municipality of Central Manitoulin, under the Authority of Section 34 of the Planning Act, R.S.O. 1990, Chapter P. 13, as amended.

Whereas, the Municipality of Central Manitoulin, has ensured that adequate information has been made available to the public, and has held at least one (1) public meeting after due notice for the purpose of informing the public of this by-law;

And Whereas, Council deems it appropriate to concur, whereby Restricted Area Zoning By-law No. 2002-07 is amended to rezone from Agriculture (A) Zone to Rural (R) Zone and to permit a 'Tourist Cabin Establishment' consisting of five (5) cabins within land described as Part Lot 12, Conc. IV, surveyed as Part 10, Plan 31R-3285, (Located at #690D Perivale Road West), Township of Campbell, Municipality of Central Manitoulin, District of Manitoulin.

And Whereas, upon considering representations in respect to the zoning proposal and the report of the Secretary-Treasurer of the Manitoulin Planning Board, the Council of the Municipality of Central Manitoulin, deems it advisable to amend Zoning By-law No. 2002-07, as amended.

Now Therefore, the Council of the Municipality of Central Manitoulin, enacts as follows to:

- (1) Rezone from Agriculture (A) Zone to Rural (R) Zone; and
- (2) Amends Section 8, Special Provisions of the Restricted Area Zoning By-law No. 2002-07 to add the following Subsection 8.106

To permit on a Site-Specific basis, a 'Tourist Cabin Establishment' consisting of five (5) cabins defined as:

'shall mean an establishment comprising land and buildings under single ownership where individual cabins are offered for rent to tourists on a short-term basis. Such cabins may include food preparation facilities. In addition, a permanent residence for the owner or proprietor may be located on the site.'

within land described in Subsection (3)

- (3) Subsections (1) and (2) apply to that parcel of land described as Part Lot 12, Conc. IV, surveyed as Part 10, Plan 31R-3285, (Located at #690D Perivale Road West), Township of Campbell, Municipality of Central Manitoulin, District of Manitoulin, as registered in the Land Registry Office for the Registry Division of Manitoulin (31).
- (4) All other uses, performance standards and provisions of Restricted Zoning By-law 2002-07, which apply to the Rural (R) Zone hereby apply to the land described under Subsection (3) of this By-law.
- (5) That it is hereby certified that this amending By-law is in conformity with the Official Plan for the District of Manitoulin.
- (6) Schedule "A" hereto attached shall be considered to be part of this By-law.
- (7) This by-law shall come into force in accordance with the provisions of Section 34 of the Planning Act, R.S.O. 1990 Chapter P. 13 and take effect on the date of its final reading subject to the expiration of the 20 day appeal period, provided in Section 34(19) of the Planning Act and subject to the approval of the Local Planning Appeal Tribunal (LPAT) where objections to this by-law are filed with the Municipal Clerk together with the prescribed fee.
