AND WHEREAS the users of the system could realize substantial cost savings by combining the operation of all municipal systems within the Province into a single corporate entity,

NOW THEREFORE BE IT RESOLVED that the Council of the Municipality of Central Manitoulin requests that the Province of Ontario assume ownership of all municipal drinking water systems within the province,

AND FURTHER that the Province assume responsibility for the operation of all municipal drinking water systems subject to its regulations and oversight,

BE IT FURTHER RESOLVED that this resolution be distributed to all municipalities within the Province of Ontario and with a request that they pass a similar resolution for submission to Premier Dalton McGuinty, the Association of the Municipalities of Ontario and both the Ministry of Municipal Affairs and Housing and the Ministry of the Environment...carried.
