WHEREAS the gap between the transfer from the province and the cost of social programs is growing and is now estimated by the Association of Municipalities at over \$3 Billion; and

WHEREAS delays in balancing the cost of delivering services with the ability to pay are resulting in delayed maintenance of infrastructure, reduced municipal services and property tax increases across the province;

NOW THEREFORE BE IT resolved that in the opinion of the Council of the Township of Central Manitoulin that the provincial government's currently proposed Provincial-Municipal Fiscal and Service Delivery Review (which will not be completed until February 2008, after the next provincial election) is needlessly drawn out and that a full review to balance the delivery of service with the ability to pay should be completed much more expediently, in order to avoid hitting taxpayers with unsustainable property tax hikes or significant reductions in services...carried.

WHEREAS Frank's Rd is a public road belonging to the Township of Central Manitoulin, and

WHEREAS the landowners of the Hutchinson Subdivision and David Pryor agreed to pay in 1998 to have Frank's Rd. brought up to municipal standards, and

WHEREAS many of the Hutchinson Subdivision landowners have financed the costs of this road reconstruction over 10 years, and thus will not make their final payments until 2008, and

WHEREAS landowners of properties beyond the boundaries of the subdivision have expressed the wish to be granted use of Frank's Rd., without having made a contribution to the cost of the road reconstruction, and

WHEREAS the council recognizes that although Frank's Rd. is a public road, the use of which cannot be denied, free access to it by neighbouring landowners creates the appearance of an injustice to those who are still paying for the upgrades, and

WHEREAS Council has the right to grant or refuse neighbouring land owners right of way across the one foot reserve onto Frank's Rd.,

THEREFORE BE IT RESOLVED that should Mr. & Mrs. Dean wish to use Frank's Rd. as the access to their property, that they be advised that payment is required for right of way access across the one foot reserve onto Frank's Rd. at a cost of \$786.48 per year until the end of the amortization period for Frank's Rd. or a lump sum payment equivalent to the principal balance owing on the amortized loan, and that these funds be placed in a reserve to be used on capital construction and maintenance of Frank's Rd, and

That adjacent landowners must continue to use the traditional means of access to their properties unless granted right of way access by council and that if need be, a verbal or written agreement be made concerning the placement of snow from the road plowing during the winter season...carried.

That we approve the new road department vehicle be a capital purchase for the amount of \$191,134.68, with \$10,000.00 to be paid from the amounts budgeted and the remaining \$181,134.68 of the purchase cost to be financed through the Bank of Montreal on a five-year term, with monthly payments at a fixed rate of 6.56%...carried.
