That the minutes of the last regular meeting of October 11, 2007 be approved as presented...carried.

### 373-07 MOTION: Witty and Tribinevicius

WHEREAS the Central Manitoulin Seniors Committee ("Committee") has determined that there is a need for a Seniors Apartment complex in the village of Mindemoya and have undertaken to secure a ten acre parcel of land and have located a building contractor willing to finance and construct the first phase of the proposed housing complex.

And, WHEREAS the Committee has approached the Municipality of Central Manitoulin to acquire the above noted ten acres and hold them in trust for future development of housing for seniors

And, WHEREAS there is a need to supply the above noted development property with access to Municipal water and sewer connections.

Be it resolved that the Municipality of Central Manitoulin agrees to acquire the above noted development property for a negotiated cost of \$80,000, and further that the Municipality will undertake to provide water and sewer connections to the property line at an maximum cost of \$70,000.

And further, BE IT RESOLVED that the Clerk/Treasurer investigate all possible financial assistance programs pertaining to these development costs, and if funding is available, that the necessary applications be prepared and submitted...carried.
