Council Update Report - D. Scott

- Property Committee received memo outlining strategy and general format for municipal building actions proposed by the CAC in the CEEP
- Property Committee members provided some general feedback, mainly that they liked the table and accepted the goals outlined for energy efficiency in municipal building. Suggested no major changes for the CAC to consider at this time, recommended carrying on to last sections

Old Business

- a) Survey Launched to public on earth day great feedback and comments received, news coverage in Manitoulin Expositor and the Hamilton Spectator!
- Delivered prizes to compost winners thanks Cori and Dale for helping do the prize draw!
- c) CCC provided update that contract ends on May 28, 2021
- d) Cost projections for design, printing, and advertising campaign once CEEP is approved at Council:
 - Wait for OJ Graphix detailed breakdown and quote
 - Only print a few copies for the office
 - o Lets not do another advertising campaign use our own posters and social media
 - o Committee member suggests getting a few more copies printed and sell them for fundraising
 - A consensus was made on getting a better breakdown from OJ graphix and Ethelo for design and printing only – CCC adjust attached memo with motions for Property Committee consideration at before May 11th Property Committee meeting

- Consider sending our draft CEEP for design after May 11th so a final version that can be printed and posted on the website is available before the May 27th Council meeting where the CEEP is expected to be approved
- e) CEEP Natural Shared Spaces Collaborative Partnership: CCC provided update to committee on presentation to Manitoulin Streams board on Monday April 19th providing overview of some of the opportunities that are available for collaboration between Manitoulin Streams/Central/Billings to implement some of the natural shared spaces actions that were supported in the climate change survey, mainly aquifer/source water monitoring program, natural asset inventory which can be used to develop a regional natural asset management plan and flood mapping/wildfire vulnerability assessment.

 Manitoulin Streams board was supportive of pursuing a joint project like this but only if other communities could also be included they also provided CCC permission to include them in the CEEP as a supporting partner for some of these initiatives.

One joint application was discussed at the Manitoulin Streams board meeting that this project would qualify for – Climate Action and Awareness Fund. If Central/Billings agreed to pursue this grant with Manitoulin Streams, Manitoulin Streams would need to take the lead position and municipalities would be listed as supporting partners with a minimum annual financial contribution for the project over 3yrs.

How to start moving a project like this forward is outlined in current draft CEEP for further discussion at this meeting.

New Business

Draft CEEP – Review by Section:

Mayor/Co-Chair welcome letter at the start of CEEP:

- Dale and Cori can work on this
- o CCC to send 2 examples to them
- Try and get letter done before May 4th/5th latest May 10th before the property committee

Indigenous Land Acknowledgement:

- CCC has reached out to three local indigenous women and leaders from M'Chigeeng, AOK and Wiikwemkoong – no responses yet, looking for an accuracy check and general feedback
- o Does CCC have time to take this to UCCM before CEEP is published? No.
- Suggestion to send CEEP to UCCM with a joint letter from Central/Billings requesting them to review the collaborative model strategy and determine if they would like to pursue any of the community actions listed in the CEEP
- In consideration of partnership with Manitoulin Streams and their strong relationship with Wiikwemkoong and AOK on sucker creek – perhaps this could be where we seek to build on a joint/collaborative project (after CEEP is approved by Council)
- o Could we reach out to Autumn Peltier for a contribution on this introduction?
- Include local indigenous artwork on this page in the report?
- Translate land acknowledgement to Ojiibway?

CCC – these are all amazing ideas, very happy to be working on this on behalf of the municipality. Not sure if it will be possible to implement all of these great ideas before the CEEP is due. At minimum, need at least two people to fact check the work. (Update as of 7pm CAC Billings meeting – Mayor Anderson provided some factual corrections, CCC sending these corrections to around for confirmation).
