- 2. Tipping fee for the garbage is set at \$200/tandem;
- 3. All larger stones must be removed from the soil prior to transport, only 6 inch minus will be accepted.
- 4. The soil must be chemically tested before transport and must meet the requirements of our current certificate of approval;
- 5. Tipping fees for the soil is set at \$200/tandem;
- 6. Current tipping fees will apply for any items already listed in our tipping fee schedule (i.e. construction waste, shingles, etc), all item must be sorted and disposed of in their correct locations...carried.
