BY-LAW NO. 2013-19

## Being a By-law to Amend Zoning By-law No. 2002-07

**Being a By-law** for the purpose of amending Zoning By-law No. 2002-07, being a By-law, to regulate the Use of Land of the Corporation of the Municipality of Central Manitoulin, under the Authority of Section 34 of the Planning Act, R.S.O. 1990, Chapter P. 13, as amended.

Whereas, the Corporation of the Municipality of Central Manitoulin, has ensured that adequate information has been made available to the public, and has held at least one (1) public meeting after due notice for the purpose of informing the public of this By-law;

And Whereas, Council deems it appropriate to concur, whereby Restricted Area Zoning By-law No. 2002-07 is amended, despite Sections 6.19 a) and 6.19 b)(i), will by Special Provision, Section 8, (i) permit the number of required parking spaces, within Lot 11, Conc. XI, containing a church, to be reduced from 29 spaces to 14 spaces, and (ii) permit an area of 115 ft. X 100 ft., being the north west corner of Lot 10, Conc. XI, to be used for additional parking, within a Hamlet (H) Zone, Township of Campbell, Municipality of Central Manitoulin, as registered in the Land Registry Office for the Registry Division of Manitoulin (31).

**And Whereas,** upon considering representations in respect to the zoning proposal and the report of the Secretary-Treasurer of the Manitoulin Planning Board, the Council of the Municipality of Central Manitoulin, deems it advisable to amend Zoning By-law No. 2002-07, as amended;

**Now Therefore,** the Council of the Corporation of the Municipality of Central Manitoulin, enacts as follows to:

- (1) Section 8, Special Provisions, is hereby amended to add the following Subsection 8.73:
  - (i) Despite Section 6.19 a) the number of required parking spaces, within Lot 11, Conc. XI, shall be reduced from 29 parking spaces to 14 parking spaces; and
  - (ii) Despite Section 6.19 b)(i) an area of 115 ft. X 100 ft., being the north west corner of Lot 10, Conc. XI, shall be used for +15 parking spaces.
- (2) That Subsection (1) applies to that parcel of land described as Part of Lots 10 and 11, Conc. XI, identified as #9351 Hwy No. 542, Township of Campbell, Municipality of Central Manitoulin, District of Manitoulin, as registered in the Land Registry Office for the Registry Division of Manitoulin (31).
- (3) All other uses, performance standards and provisions of Restricted Zoning By-law 2002-07, which apply to the Hamlet (H) Zone, which are not specifically varied hereby continue to apply to the land described under Subsection (2) of this By-law.
- (4) That it is hereby certified that this amending By-law is in conformity with the Official Plan for the Manitoulin Planning Area.
- (5) Schedule "A" hereto attached shall be considered to be part of this By-law.
- (6) This by-law shall come into force in accordance with the provisions of Section 34 of the Planning Act, R.S.O. 1990 Chapter P. 13 and take effect on the date of its final reading subject to the expiration of the 20 day appeal period, provided in

Section 34(19) of the Planning Act and subject to the approval of the Ontario Municipal Board where objections to this by-law are filed with the Municipal Clerk together with the prescribed fee.
