That Council create a committee named the Mindemoya Arena Board consisting of members of the executives of Mindemoya Minor Hockey Association, the Figure Skating Club, the Lakers Hockey Club and the Hackers Hockey Club along with one Township staff member, one Council member and members of the public and further that we appoint Councillor Tribinevicius to this board as Council's representative...carried.
