#### **COUNCIL MEETING MINUTES**

#### **SEPTEMBER 28, 2017**

The Mayor called the meeting to order at 7:30 p.m.

#### 238-17 MOTION: Baran and Scott

That the agenda be approved with the addition of Bill Cranston as the third delegate...carried.

#### 239-17 MOTION: Taylor and D. Stephens

That the minutes of the last regular Council meeting held on September 14, 2017 be approved...carried.

Keith Harfield was introduced as the first delegation. Mr. Harfield supports turning the Old School into something more productive and having further time to come up with ideas to do so.

Ted Williamson, on behalf of some of the Historical Society members and other interested individuals spoke to Council next. Mr. Williamson also wanted to see an extension of time to consider what could be done with the Old School and further suggested that a sub committee of Council be struck to come up with a sound and viable business plan for the Old School, exploring ways to fund upgrades need to the building.

may be subject to terms and conditions, including but not limited to, the provision of liability insurance naming the Municipality of Central Manitoulin as an additional insured, be given its several readings and be duly passed...carried.
