Whereas there are approximately one million (1,000,000) tires located on Zhiibaahaasing First Nation land on Manitoulin Island,

And Whereas these tires represent a serious threat to Manitoulin Island, the North Shore communities, Cockburn Island, the North Channel and Lake Huron in the form of fire, health concerns, and West Nile virus,

And Whereas Manitoulin Island communities do not have the required resources to combat a fire of this magnitude,

And Whereas the economic and environmental impact of a tire fire on Manitoulin and surrounding areas would be devastating,

And Whereas Zhiibaahaasing First Nation has no immediate plans in place for the processing or removal of these tires,

Therefore be it resolved that the Township of Central Manitoulin demand that all necessary steps be taken for the immediate removal of all tires from the Zhiibaahaasing first Nation and legislation be put in place to regulate the stockpiling of tires of federally designated land...carried.

That Council go out to tender the 2006 Waste Collection, Recycling Collection and Processing Services Contract with a single bid sheet for combined garbage and recycling collection...Motion withdrawn.
