#### 196-11 MOTION: McDonald and Stephens

That the agenda be approved as presented...carried.

There were no declarations of pecuniary interest.

#### 197-11 MOTION: Smith and Haner

That the minutes of the last regular meeting of May 26, 2011 be approved as presented...carried.

There were no delegations.

## 198-11 MOTION: Stephens and Smith

That By-law 2011-10, being a by-law to amend restricted area zoning By-law 2002-07, be given its several readings and be duly passed...carried.

#### 199-11 MOTION: Stephens and MacDonald

That Council direct that the Municipality restart the public meeting process under the Planning Act to have the issue of the usage of storage containers revisited...carried.

#### **200-11 MOTION: McDonald and Stephens**

That Council waives the fine for an outstanding dog tag for Henry Forget due to health issues pending his purchase of his 2011 dog tag, and further that any future correspondence for Mr. Forget be sent in care of Mr. Douglas Hutchinson...carried.

#### **201-11 MOTION: Stephens and Haner**

That Council approves that the three outstanding fines for failure to license dogs be sent a letter stating that if they do not pay their fines by a certain date that court action will ensue...carried.

## 202-11 MOTION: Stephens and Smith

That Council approves that the Municipality send letters to the two businesses (three locations) who have not installed proper buffer zones (due May 31st, 2011) stating that if they do not have the buffer zones installed by a certain date that further actions will take place...carried.
