- 1. Gravel will be placed as needed
- 2. Road way will be graded as needed
- 3. Proper signage be installed for safety
- 4. Calcium applied
- 5. MTO assumes liability of the road during the detour
- 6. MTO to determine if the roadway is safe for detour traffic volumes

- 7. That the roadway be returned to the Municipality in good or better condition than when taken over.
- 8. That the Municipal Road Superintendent be consulted at all times on the above items.....carried.
