1.	The Corporation of the Municipality of Cen	ntral Manitoulin	_may, subject to	
	the provisions of this by-law, borrow on the credit of the	e Corporation such sums not exceeding in the whole	\$50,000.00	
	as determined by the council, and may issue debenture	es of the Corporation for the amount borrowed as pro	vided in the Act	
	payable to the Minister of Finance, which debentures shall reserve the right to prepay the whole or any part of principal and			
	interest owing at the time of such prepayment.			
2.	Where an application for a loan under the Act is approved by the council and the inspector of drainage has filed with the clerk			
	an Inspection and Completion Certificate, the council may include a sum, not exceeding the amount applied for or seventy-five			
	percent of the total cost of the drainage works with respect to which the loan is made, in a debenture payable to the Minister of			
	Finance in accordance with the Act, and may approve of the Corporation lending the said sum to the applicant.			
3.	A special annual rate shall be imposed, levied and collected over and above all other rates upon the land in respect of which			
	the money is borrowed, sufficient for the payment of the	e principal and interest as provided by the Act.
