

MUNICIPALITY OF CENTRAL MANITOULIN  
COUNCIL MEETING MINUTES  
MAY 27, 2010

Attending: Reeve Stephens, Councillors Bowerman, Hill, McCutcheon, Orford, Smith and Tribinevicius, along with the Clerk and the CBO, one member of the press and eight members of the public.

The Reeve called the meeting to order at 7: 40 p.m.

**181-10 MOTION: Tribinevicius and Smith**

That the agenda be approved with the following additions: items 7 b) Carol Hughes, MP – email and 7 c) Jan McQuay-email.....carried.

There were no declarations of pecuniary interest.

**182-10 MOTION: Hill and Bowerman**

That the minutes of the last regular meeting of May 13, 2010 be approved as presented.....carried.

**183-10 MOTION: Hill and Bowerman**

That the Municipality pay the approximately \$200.00 that it will take to renovate the ball field in Spring Bay.....carried.

**184-10 MOTION: Tribinevicius and Smith**

That we request that the CBO do more research on By-law 2010-19 and bring this information back to the next Finance, Public Relations, and Economic Development Committee meeting of June 3, 2010.....carried.

**185-10 MOTION: Smith and Bowerman**

That By-law 2010-17 be sent back to the next Finance, Public Relations, and Economic Development Committee meeting of June 3, 2010, to consider changing it to a site specific by-law.....carried.

**186-10 MOTION: Orford and McCutcheon**

That Council direct the Clerk to purchase a more noticeable sign for the Welcome Centre stating “ Information and Washrooms” and further that the municipality cut all the grass on the east side of Hare’s Creek.....carried.

**187-10 MOTION: Hill and Tribinevicius**

That Council approves that Bill Rumble be hired as the replacement landfill site attendant at the same hourly rate as the other workers, with a 8 week trial period.....carried.

**188-10 MOTION: Bowerman and Smith**

That Council approves the Office and Administration Committee Financial report to April 30, 2010 as presented.....carried.

**189-10 MOTION: Smith and Bowerman**

That Council approves paying the Central Manitoulin Lion’s Clubs invoices for the Old School pavilion through municipal accounts, provided that they are reimbursed by the Club and that the actual Lion’s Club meeting motion is provided to the municipality indicating that this is what the Club would like to do.....carried.

**190-10 MOTION: Orford and Tribinevicius**

That Council thank Jan McQuay for her volunteer work with establishing a Welcome Centre Information booth group to man the booth during June and September and that they be authorized to have access to the facility by Council.....carried.

**191-10 MOTION: Bowerman and Smith**

That any action taken at tonight's meeting which may require a by-law be so authorized by Council...carried.
