

**MUNICIPALITY OF CENTRAL MANITOULIN**  
**By-law No. 2020-04**

**Being a by-law to establish a Water & Sewer Service Rates**  
**In the area known as the Village of Mindemoya**

WHEREAS, Sections 8 and 28 of the Public Utilities Act authorize a municipality to pass by-laws establishing water service rates for the provision of municipal water service;

AND WHEREAS, the Municipality of Central Manitoulin (the "Municipality"), owns a water works system which provides water service to a portion of the municipality, namely the area known as the Village of Mindemoya, (the "Water Works");

AND WHEREAS, water meters have been installed at commercial & industrial buildings in the Village of Mindemoya;

NOW THEREFORE, the Council of the Municipality of Central Manitoulin hereby enacts as follows:

1. For the year 2020, the annual flat rate fee for each Residential water unit in the Village of Mindemoya shall be \$173.47 per quarter.
2. For the year 2020:
  - a. The quarterly minimum fee for each Commercial water customer in the Village of Mindemoya shall be \$173.47.
  - b. In addition to clause 2(a), each meter shall be read quarterly and any usage will be billed at the rates established as follows:

0 - 75 cubic meters	billed in accordance with clause 2(a)
76 - 250 cubic meters	\$0.868
251 - 400 cubic meters	\$0.924
401 - more	\$0.308
3. For the year 2020, the annual flat rate fee for each Residential sewer unit in the Village of Mindemoya shall be \$224.53 per quarter.
4. For the year 2020:
  - a. The quarterly minimum fee for each Commercial sewer customer in the Village of Mindemoya shall be \$224.53.
  - b. In addition to clause 4(a), Commercial sewer customer shall be billed quarterly and any usage will be billed using the same consumption rates as water at the rates established as follows:

0 - 75 cubic meters	billed in accordance with clause 4(a)
76 - 250 cubic meters	\$0.868
251 - 400 cubic meters	\$0.924
401 - more	\$0.308
5. Interest shall be charged on past due water usage fees at the rate of 1.25% per month and added on the first day of each and every month.
