COUNCIL MEETING MINUTES

MARCH 14, 2019

53-19 MOTION: Farquhar and Scott

That the agenda be approved...carried.

There were no declarations of pecuniary interest.

54-19 MOTION: Scott and Tribinevicius

That the minutes of the last regular meeting of Council held on February 28, 2019 be approved...carried.

55-19 MOTION: D. Stephens and Tribinevicius

That By-law 2019-06, being a by-law to amend restricted area zoning By-law 2002-07, be given its several readings and be duly passed...carried.

That Council approves the Clerk writing a letter to the OPP requesting clarification on the agency's roles and responsibilities on Municipal roadways, especially regarding abandoned vehicles, as the Road Committee feels that this is a safety issue to the public...carried.

That Council approve the Clerk writing a letter to the Ministry of Transportation requesting clarification on the Ministry's responsibilities regarding curb to curb snow removal, focusing on why the parking lanes in Mindemoya have not been cleared of snow, as the Committee feels that this is a safety issue for the public and further that we express our concerns over flooding potential because the parking lanes and storm drains have not been cleared of snow...carried.
